





<p>I hereby make application to book a CMH Heli-Skiing (also referred to as "CMH") ski trip, and I understand and agree to each and all of the following 9 terms &amp; conditions:</p> <ol style="list-style-type: none"> <li>1. That all rates and deposits are in Canadian funds, and that an allowance will be made for exchange if payment is in foreign currency. Where applicable, rates are subject to change without notice to me.</li> <li>2. That my initial deposit of \$1,000.00 per person, for trips of 7 days duration or longer, and/or my deposit of \$500.00 per person, for trips of 5 days or less in duration, for each trip that I am applying to book is non-refundable. This deposit is transferable only under the following conditions:       <ul style="list-style-type: none"> <li>- A replacement guest is found to be available.</li> <li>- A replacement guest by the same booking name/age is given to CMH. You are responsible to find this replacement guest.</li> </ul> </li> <li>3. New Booking - If, 4. completely new reservations which is not associated to my existing booking. Calendar Year = January 1 through December 31, although the Sommer Adventure season: October 1 through April 30, and the Sommer Adventure season: August 15 through September 30.</li> <li>4. I acknowledge that an administration fee of \$200.00 (plus applicable taxes) will be charged to my account for any transfer required under this Section 2.</li> <li>5. That full payment for all helicopter ski trips are due and payable at the Banff office prior to 10 weeks before the commencement date for all trips booked, and that in cases where there is a full payment, no monies received more than 10 weeks ahead of time, CMH reserves the right to release these funds to persons on the waitlist. Payment, less full payment for all helicopter ski trips are deposited as deposit.</li> <li>6. That the initial \$1,000.00 or \$500.00 deposit is applied to assist in holding a specific position, that transfers from waitlist to confirmed bookings (Cabin will cost to confirm) will be made automatically as soon as space becomes available, and that CMH will not hold any of my cabin in writing. Also, that following any such transfers to confirmed bookings, the non-refundability clause on the initial \$1,000.00 or \$500.00 deposit will come into immediate effect. And further, that persons remaining on waitlist, can retain their initial \$1,000.00 or \$500.00 initial deposit at any time.</li> <li>7. In the event of cancellation, an administration fee of \$200 (plus applicable taxes) will be charged. Further, all cancellations must be heard out by telephone and confirmed in writing or by email to CMH at its Banff address. If cancellation is received by CMH less than 10 (10) weeks before the date of trip commencement and if I can find a replacement for the trip booked, any and all deposits will be transferred to my replacement. If cancellation is received by CMH less than ten (10) weeks before the date of trip commencement and I cannot find a replacement for the trip booked, the total of all deposits for helicopter ski trips will be retained by CMH. Deposits cannot be transferred to any other winter season, other than as stated in section 2 above.</li> <li>8. That I will not be permitted to participate in any CMH ski trip unless a "CMH Heli-Itinerary Waiver" in the form herein is properly completed.</li> <li>9. That it is my responsibility to arrive at CMH departure sites at the required times, and it is my responsibility for any extra costs incurred if I miss the scheduled departure times. It is also my responsibility to ensure proper entry through Canadian Customs and Immigration if entering from USA/US/Canada. Refunds of payment made will not be given in cases where entry into Canada is denied.</li> <li>10. That in the case that I am a Pre-Payment Series holder, that my credit pursuant to my subscription shall be treated in the same manner as a normal deposit.</li> <li>11. I understand that CMH reserves the right to take photographs and film records of any of its trips and hereby agree that CMH may use any such photographic or film records for promotional and/or commercial purposes, as well as approve such use by third parties with whom CMH may engage in joint marketing, without any remuneration to me. **WARNING: THIS AGREEMENT CONTAINS A RELEASE OF LIABILITIES. READ IT CAREFULLY!**

In consideration of CMH (as defined below) accepting my application for participation in its participation in a heli-skiing operation ("CMH Heli-Ski Trip") on lands owned by or under the control of CMH or the Person(s) (as defined below) located anywhere, the following waiver of all claims, releases from all liability, assumption of all risks, agreement and/or to use and terms of this agreement ("CMH Heli-Ski Waiver") are entered into by me with and for the benefit of:

"Canadian Mountain Holidays L.P."  
doing business as "CMH Heli-Skiing"  
and "Aigle Helicopters Inc."  
and their respective affiliates  
and subsidiaries (collectively, "CMH")

And  
Her Majesty the Queen in Right of the  
Province of British Columbia ("Provincial")  
and  
the "Province" (as defined below).

I waive any and all claims that I have or may in the future have against, and release from, all liability and agree not to sue, CMH, the Province and any of their shareholders, directors, officers, employees, servants, helicopter skiing guides, helicopter pilots, helicopter maintenance personnel, agents, contractors, suppliers, representatives, and other guests (collectively, the "Person(s)") for any personal injury, death, property damage or other loss that I sustain during or as a result of any CMH Heli-Ski Trip or, to the greatest extent allowed by law, any claim for damages resulting from my participation in the CMH Heli-Ski Trip.

(a) I waive any and all claims that I have or may in the future have against, and release from, all liability and agree not to sue such names as a manufacturer, product, and/or service provider would use under similar circumstances and feature-to-feature standards of care in the helicopter skiing industry in the Province of British Columbia (for the safety of heli-skiing);

(b) breach of any other duty imposed by law, including any duty imposed by occupiers liability or other legislation;

(c) breach of any contract; and

(d) negligence or want of reasonable care.

I give notice of the risks inherent in heli-skiing and I am aware that helicopter skiing has certain additional dangers and risks, including but not limited to:

**AVALANCHES:** I am aware that avalanches frequently occur in the mountainous terrain used for helicopter skiing and that avalanches have caused a number of fatalities involving heli-skiing. If I use a snowboard or telemark skis, I am aware that there is the potential that I will not survive an avalanche if the snowboard or telemark skis do not have a binding release mechanism. I am aware that the risk of an avalanche is always present in helicopter skiing, that this risk is increased when the terrain is steep, and that the risk of an avalanche is increased when the terrain is heavily forested. I am aware that the negligence (or lack thereof) of CMH or the Person(s) to correctly assess the terrain and safety of a slope for skiing is no protection when or when an avalanche occurs.

**MOUNTAIN TERRAIN:** In addition to avalanches, I am aware that the rugged mountain terrain used for helicopter skiing has many other dangerous obstacles and hazards including glacial crevasses, rock outcroppings, cornices, cliffs, heavily treed areas with fallen trees and tree stumps, creeks, and boulders and also man-made hazards such as leaping deer cuts, logging roads, road berms and ledges that cross heli-skiing slopes; that certain hazards may be hidden by snow, and that certain hazards are present in or near a severe winter weather condition; as difficult terrain areas as a risk of safety in making descent.

**TREE WELLS:** I am aware that tree wells (also known as "tree veins") in the snow between trees on exposed slopes for helicopter skiing can be a serious hazard to heli-skiing operations and that a number of fatalities have occurred due to tree wells.

**OTHER HELL-SKIERS:** Heli-skiers pay in groups or with partners and I am aware of the risk of colliding with other heli-skiers and the risk of being separated from other heli-skiers by becoming lost.

**HELICOPTER TRAVEL:** I am aware of the risk of mechanical failure or operational error involving pilot error in the operation of helicopters and that there are increased risks of helicopter travel in mountainous areas, especially in winter weather conditions.

**EQUIPMENT:** I am aware of the risk that the equipment used during a Heli-Skiing trip such as, but not limited to, Aviations Transmissions, Aviations Flightline Devices, etc., will experience breakdowns, snags, power failure, and hence, whether or not they are provided by CMH, supplied by third parties, or brought to CMH, I am aware that they have been designed or manufactured as designed or as intended. I am aware that regardless of the functionality of such equipment, the use of such equipment may not prevent injury or death.

**WEATHER:** I am aware that weather conditions may be extreme and can change rapidly without warning.

**TRANSPORTATION TO AND FROM AREA:** I am aware of the risks associated with transport through mountainous areas including rapidly changing road and highway conditions and the risks of using aircraft, motor coaches, vans, tankers, and other vehicles which may or may not be owned and/or operated by CMH.

I acknowledge and accept all the risks and dangers of helicopter skiing and the possibility of personal injury, death, property damage or other loss (as a result). I agree that, although CMH and the Person(s) may take precautions to reduce the risks and increase the safety of helicopter skiing and to determine whether a particular slope is safe for the risk of avalanche or other hazards before it is skied, it is not possible for CMH or the Person(s) to insure helicopter skiing completely safe or to predict with certainty whether the terrain to be skied is safe from the risk of avalanches. I willingly accept these risks and agree to the terms of this CMH Heli-Ski Waiver even if CMH or any of the Person(s) are found in law to be negligent or in breach of a duty of care or any other obligation to me in their conduct of any CMH Heli-Ski Trip.

I am aware that the enjoyment and excitement of helicopter skiing is derived in part from skiing in powder snow on steep un groomed slopes and is contributed to by the interest rates of helicopter skiing.

I am signing this CMH Heli-Ski Waiver, I am not relying on any oral, written or visual statements of any kind, including promotional statements made by CMH in any brochure, magazine, printed material or electronic media, or by any of the Person(s) or by the Province to induce me to sign on a CMH Heli-Ski Trip.

I confirm that I am of the full age of nineteen years, that I have had sufficient time to read and understand what I am agreeing to in this CMH Heli-Ski Waiver (except signing it) and that it will be binding upon my heirs, next of kin, executors, administrators and successors.

I agree that the CMH Heli-Ski Waiver and the agreements it contains will be governed exclusively in all respects by and interpreted solely in accordance with the laws of the Province of British Columbia. I hereby irrevocably submit to the exclusive jurisdiction of the courts of the Province of British Columbia and I agree that no other courts can exercise jurisdiction over the agreements and claims referred to herein. Any litigation to enforce this agreement shall be instituted in the Province of British Columbia and nowhere else.

I agree that the terms "Heli-skiing", "Heli-skier" and "Heli" herein include snowboarding, mono-skiing, telemark skiing, ski touring, snowshoeing and other similar activities and the term "Heli-ski" includes snowcat, moni-ski, telemark skier, ski tourer and snowshoer.







## Access Code

If you do not appear to be receiving an email containing the access code to access the waiver form; please verify both your inbox and junk mail folders.

If the access code you enter is denied more than 3 times, it will cancel the current form; in order to ensure the access code you enter is valid, please select, copy, and paste it into the indicated field box.

If this doesn't solve the issue, it may be that too many people are trying to access the waiver form at once. Please try again at a later time.

## Children Under 19

If you completed the online waiver and are under 19 years of age, or if you completed the online waiver for your child who is under 19;

you will be contacted by a CMH agent, as the waiver form will be considered invalid.

Children under 19 must have an original paper waiver signed by a parent or guardian, with a witness to the signature.

## Waiver Form

If you send in a scanned or faxed copy of your paper waiver, or if you printed and completed the online waiver on paper;

you will be contacted by a CMH agent, as the waiver will be considered invalid.

The only valid waiver forms are:

an original paper waiver mailed to the CMH Banff office, or handed in to CMH upon arrival, or the eWaiver completed electronically.

Please DO NOT print the online waiver in order to complete it by hand, as paper waiver copies MUST have a witness, which the online waiver does not require.

## Confirm eWaiver Signature

If you have completed the eWaiver, but it doesn't seem to go through the system; you will have to press on the "Confirm Signing" button in order to submit your waiver.

If you do not see the "Confirm Signing" button, but see a "Next" button; it means there is information missing on the waiver form. If you press on the "Next" button, it will take you to the field where information is missing.

Once all information is complete, the "Confirm Signing" button will appear where the "Next" button was previously.

## Confirmation Email

If you receive an email from CMH through DocuSign after having completed your online waiver; it is simply a confirmation that your waiver is complete and is being processed.
